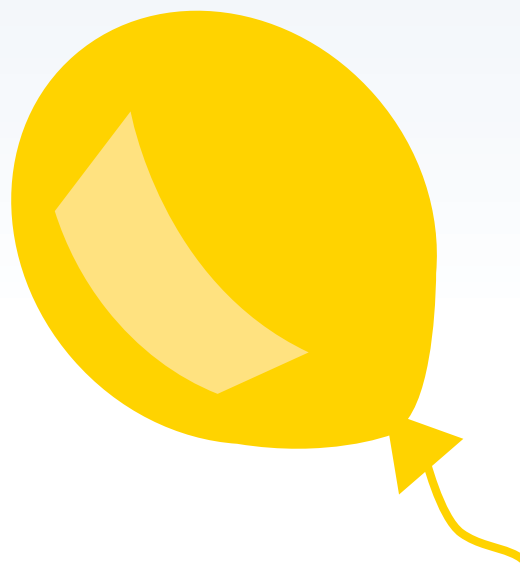

REPORT FROM THE CHAIR AND EXECUTIVE DIRECTOR

The 2019-2020 year was one of change and transformation on numerous levels. The past year was marked with the continued commitment from the Province of Ontario to transform the delivery of children and youth services for the years to come. The year also saw the retirement of two members of the Senior Leadership Team, Adele Kirby, Director of Client Services and Michael Stetch, Director of Finance. One Kids Place furthermore continued their mission to expand the development of rehabilitation services to enhance the lives of children, youth and their families in the Districts of Nipissing, Muskoka, Parry Sound, Timiskaming and along the James Bay coast.

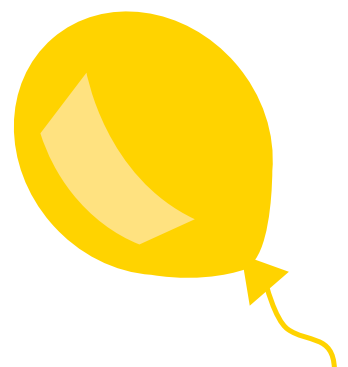
New ways of Expanding Our Service Delivery:

In North Bay, OKP is proud to have offered a summer camp experience to many children and youth with special needs through some unique partnerships. In its fifth summer, The Autism Summer Camp, funded by a generous donation from the Deacon family, is quickly becoming an exciting tradition for kids with Autism in North Bay and area. In 2018, the agency was able to expand the program into the district of Muskoka, and last summer, inspired by families sharing, there are limited opportunities for young children with Autism Spectrum Disorder (ASD) to participate in summer camps in Parry Sound. OKP therapists created a unique opportunity to envelop these kids in an interdisciplinary camp week. Throughout the week, therapists worked on social skills, a Physiotherapist stepped in to lead the bike riding day, and Speech-Language Pathologists and Communicative Disorders Assistants attended for water day to inspire language while playing. The agency received approval for a Northern Autism Services pilot that will expand access to service to families in Cochrane District (including Timmins and the surrounding area, and the HWY 11 corridor) and the District of Timiskaming Shores. One Kids Place has been one of the lead Autism Services providers in the North East since 2011, during this time it has become clear that northern rural and remote communities require a different service model. The proposal addressed building capacity of local services providers; community living associations, and local school boards. The service delivery model was developed to leverage technology and local support personnel to ensure children/youth and their families could receive service within or close to their home communities.

Conferences:

This year One Kids Place has had the opportunity to showcase the Centre on a provincial landscape by hosting two conferences. In September, in collaboration with Kim Barthel, OKP hosted the “Collaborating Clinicians” event for community partners and staff. Kim is a registered Occupational Therapist in four Canadian provinces, the United States and Singapore, evaluating and supporting a wide range of clients. She is an Advanced Neuro-Development Treatment Instructor as well as a Sensory Integration Instructor. The conference was structured into two parts- the first workshop designed to help professionals understand the importance of collaboration within family-centred practice and appreciate the connection to the trans-disciplinary model of intervention for children with special needs. The second part included a hands-on approach that welcomed clients to attend. This in turn provided for an excellent opportunity for our clinicians and families to interact with Kim and enhance our understanding and practice overall.

In partnership with the FASD North Committee, OKP hosted a conference on October 24-25, 2019 on Fetal Alcohol Spectrum Disorder (FASD) awareness. The first day focused on a panel discussion regarding “FASD and Justice” featuring discussions with a lawyer, police officer, probation officer and a parent of a young adult with FASD, moderated by Sheila Burns. As an instructor, coach and consultant on Fetal Alcohol Spectrum Disorder, Sheila is a strong advocate for improving the way FASD is addressed at local levels where those with FASD live, learn and work. Sheila focuses on capacity-building within the context of the existing system of care for the prevention, management and diagnosis of the disability. The second day of the conference centered on training to frontline clinicians and therapists on service planning for children and youth with FASD lead by Sheila. Overall, the conference explored fresh ways of identifying, understanding and prioritizing the needs of clients with atypical neurodevelopments.



REPORT FROM THE CHAIR AND EXECUTIVE DIRECTOR

Unique Partnerships to Foster Education and Growth:

In partnership with Canadore College, OKP piloted a project with the College's Occupational Therapist and Physiotherapist Assistant program. Program students were paired with an Occupational Therapist to provide general strategy workshops to parents of children and youth awaiting service. The workshops included:

- The Fine Motor Workshop for ages 3 to 5. This workshop is to help understand and gather ideas on how to support core and upper extremity strengthening as it relates to fine motor skill development.
- The Sensory Workshop for children ages 6 to 12 on the waitlist to provide them with an introductory understanding of Sensory Processing.

At the end of the session, feedback from the students on their experience was very positive. The completion of this program prompted the expanded use of Therapy Assistants within the agency to deliver generalized strategies under the supervision of an Occupational Therapist. Moving forward, these students will be implementing specialized programming for gross motor skills for specialized classrooms within the schools, shadowing Therapy Assistant sessions, implementing a new Toileting workshop for parents, and helping support the DSSAB sensory project with our lead Occupational Therapist!

For the second year in a row, OKP is pleased to have been selected as an agency to host 2 students through the "Experiential Learning Program" partnership between the North Bay District Chamber of Commerce and Nipissing University. The students provided support for a newly formed Partnership Mapping Committee. This Committee began the large task of cataloguing all the organizations that the agency partners with, and from there- evaluating the strengths and potential untapped resources of each partner relationship. The chair of the Partnership Mapping Committee has approached a select few agencies to pilot this initiative. OKP is looking forward to reviewing this information from our partners in order to strengthen our relationships in our communities!

Transfer of School-Based Rehabilitation Services in the District of Muskoka

Effective January 1, 2020, School-Based Rehabilitation Services in Muskoka were transitioned to One Kids Place from the Children's Treatment Network (CTN). School Based Rehabilitation Services includes Occupational therapy, Physiotherapy and Speech- Language Pathology services to school-aged children in their publicly-funded school. This transfer included 24 schools in the District of Muskoka the Trillium Lakelands District School Board, the Muskoka Catholic District School Board and the Near North District School Board. This was a big milestone for OKP because it represents a realignment with the agency's geography that allowed OKP to provide families with a seamless delivery of services from birth to graduation!

We gratefully acknowledge the 111 staff members for their continued pursuit of excellence, professionalism and continued commitment to the children, youth and their families.

OKP in conjunction with our co-located community partners continues to touch the lives of countless children/youth annually who receive service from this exemplary model of integration and meaningful partnership.

Our success is the community's success. With the ongoing support of our donors, partners, Board and volunteers, One Kids Place is ready for the challenges and achievements ahead.

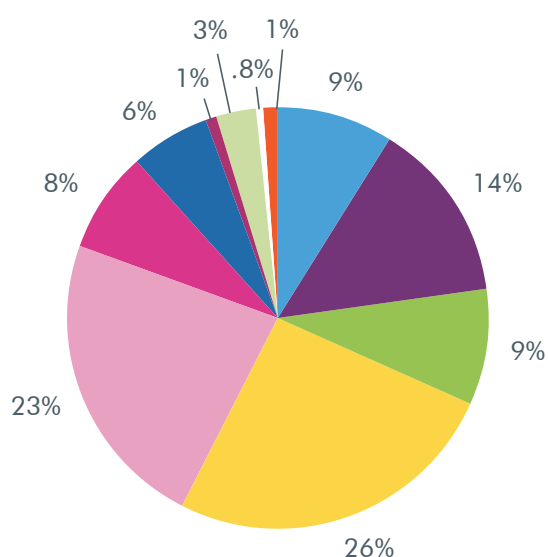

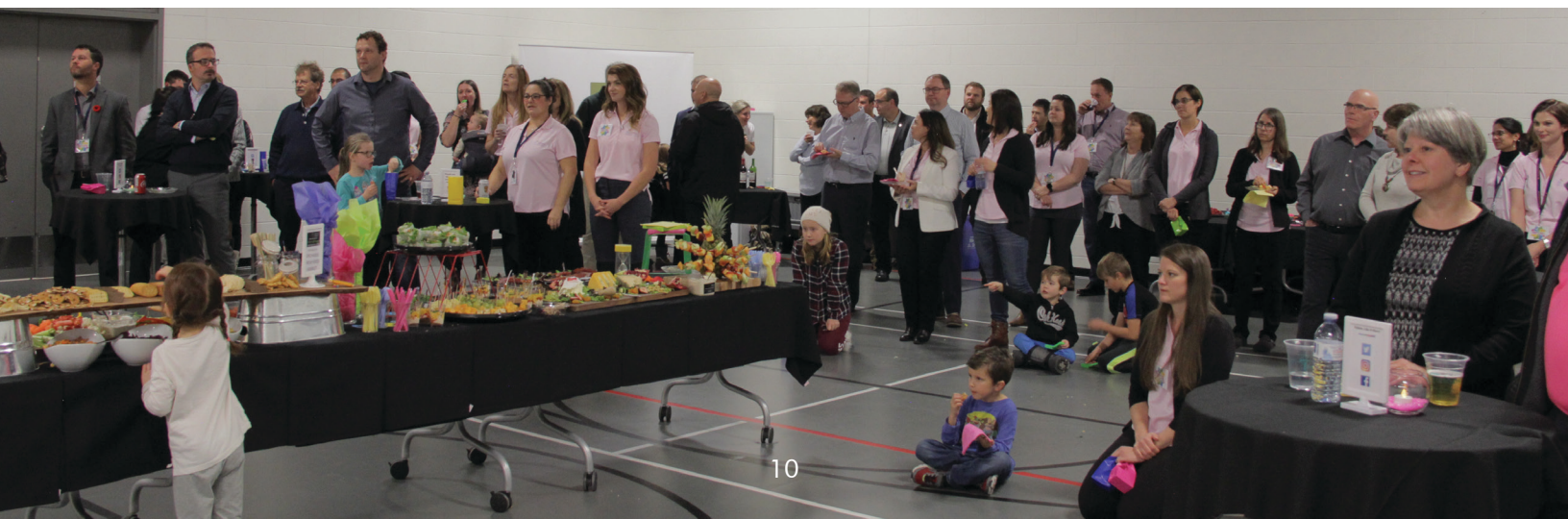

LOOKING BACK

As retired Superintendent of Education, Administrator and teacher of the Near North and West Parry Sound Boards of Education, Susan completed a 38 year career by continuing to give back to her community. Susan currently sits on the Boards of Empowered Kids Ontario, the Whitestone Lake Nursing Station, and MANITOUWABING Lake Community Association. She is a volunteer in the HELP program at the West Parry Sound Heath Centre, and she and her St. John Ambulance therapy dog Kensi visit weekly at Belvedere Heights Long-Term Care Home" and "Lakeland Long-Term Care Home. During the winter, the pair winter at Superior Residences in Panama City, Florida. Supporting children and youth with special needs has always been important to Susan both professionally and personally, and was the driving force to her pursuing her Masters of Education in special education and the reason Susan is proud to be a board member at One Kids Place Children's Treatment Centre. What are you most proud of accomplishing as a member of the Board? How has your experience as a classroom teacher and superintendent shaped your experience on the Board? I had knowledge of how a board should work, and I also had knowledge of the gaps that existed between the classroom, the home, and agencies. I, as well had some ideas as to how to narrow those gaps. I was also familiar with long range planning, outcomes and strategic plans.

What will you miss the most? The people! And the knowledge within the sector of how government decisions impact our children...not necessarily what is reported in the news, not the drive to North Bay in inclement weather, nor the videoconferencing from other countries. I have missed very few meetings as I have video linked as I travelled through the Ozark mountains, in torrential rain in Louisiana, from Graceland and during a tornado in Alabama, to name a few!

LOOKING BACK

Steven is the principal owner of Deacon Wealth Management, a corporation that works with clients to provide investment and financial advice. When Steven's oldest son, William, was diagnosed with Autism, the family began to receive services at One Kids Place. With personal experience on what a difference the staff at One Kids Place make in the lives of the children and youth, Steven wanted to lend support to OKP in any way possible. Not only has Steven become a valuable member of the Board at OKP, the Deacon family sponsors the OKP Summer Autism Program so kids like William can spend their summer vacation experiencing life lessons beyond the classroom, the value of playtime and building confidence through social skills under the guidance of OKP staff.

What are you most proud of accomplishing as a member of the Board?

As a team, this board accomplished many things, but what I am particularly proud of is the enhanced ties with the community that the Board was able to facilitate. OKP is such an incredible resource, yet not everyone knows or understands what OKP does, so strengthening ties with the communities that we serve is essential. I am also very proud of the board renewal process that we undertook - we attracted some great new members, and put in place new oversight mechanisms that will help to ensure the smooth running of the organization in the future.

Q&A

How has OKP shaped you? OKP has really energized me to look at other areas where this excellent model can be used to streamline the delivery of other services in our community. There continues to be a lot of fragmentation and empire building with other service providers, and they need to look at the OKP model to see how like-minded service providers can come together to remove duplication and deliver a fully coordinated suite of services to their shared clients.

You were part of the creation of our Strategic Plan during your time on the Board, where the vision for One Kids Place was "empowering families for a more inclusive future for our kids".... What does this mean to you and your family? As the parent of a special needs child, you can often feel alone and defeated by the magnitude of the responsibility you face. By focusing on empowering families, OKP helps to equip parents with the tools and support to not only help their child, but to help the parent or caregiver as well. Its a marathon, not a race, and having some semblance of empowerment in the process is key to a successful outcome for the children, but also for their entire family.



How has your experience as a special needs parent shaped your experience on the Board?

I would like to believe that as a parent of a special needs child, I was able to help keep things "real" and to develop policies that would enable the delivery of hands-on services and support vs. something that sounds great, but that doesn't have the same level of impact.

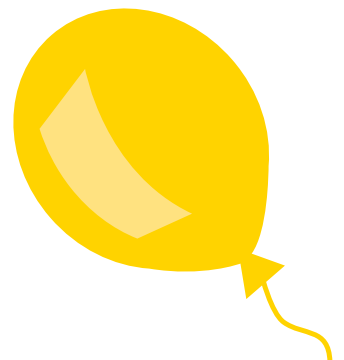
